Welcome by Luca Lantero, Head of the ASEM Education Secretariat

On behalf of Mr. Luca Lantero, Ms. Vera Lucke welcomed all members of the Expert Group on Lifelong Learning and TVET (EG3). She recounted the decision agreed during the ISOM 2022 to establish this new Expert Group, whose Terms of Reference will be decided directly by its members.

All participants briefly introduced themselves.

Discussion on updated Terms of Reference for the Expert Group 3 on Lifelong Learning and TVET and appointment of chairs

The template of the Terms of Reference of the Expert Group 3 was presented for comments.

In general, participants have approved the structure of the ToR.

The **working period** is from February 2023 to the 10th ASEM Ministerial Conference (ASEMME10) in 2026.

As for the **composition**, it was reminded that membership remains open.

Regarding the **purpose and intended outcomes**, the importance of producing benefits for both, countries and stakeholders, was highlighted.



Brainstorming on topics:

- The group should define activities, meetings, study visits, etc. How to exchange information/experience on LLL and TVET? How to build on past ASEM activities on this topic? How could countries better cooperate in this field? The group could propose a keynote speaker for the ASEMME.
- Discuss perspective from which we look at LLL and TVET as a way to upskilling and reskilling.
- Add statement about collaboration of EG with ASEM LLL Hub complementing each other and the EG's representation in the International Advisory Council of the ASEM LLL Hub.
- TVET's major trends in digitalization and sustainability: how are ASEM partners dealing
 with integrating these trends in new qualifications and competencies in order to meet the
 requirements of the labor market? Discussing concrete innovative practices and examples
 from the ASEM countries.
- Concerning digitalization: micro-credential could be discussed and other specific topics defined. How to ensure QA of these qualifications?
- Peer learning activities could be organised.
- Define if the group wants to produce papers or to organize knowledge exchange activities.
- Developments in the TVET system in different countries to cope with the rapidly changing of work.

The finalized Terms of Reference will be officially adopted at the Senior Officials' Meeting 1 that will take place in Malta on 22 and 23 May 2023.

Proposals for the appointment of chairs:

Séamus Ó Tuama, Chair of the ASEM LLL Hub Secretariat

The group approved the proposal, hence, to have as chair Mr. Séamus Ó Tuama. As no Asian country nor stakeholder proposed itself as a Co-chair and with the intention to have balance between Asia and Europe, Mr. Séamus Ó Tuama suggested reaching out to Malaysia's Expert (member of this EG3 but absent at this meeting, because of its active role in the ASEM LLL Hub. The group welcomed this idea.

In general, the chair(s) report(s) progress to the Intermediate Senior Officials' Meeting (ISOM) and Senior Officials' Meetings (SOM) and is responsible to organise group meetings, to oversee the activities and to take the minutes of this EG's meetings. The ASEM Education Secretariat supports the chair(s).

Next steps:

The Secretariat will contact Malaysia's Expert asking for her availability to become a Co-chair. The Co-chairs will propose a first version of the Terms of Reference to the group via e-mail and ask for inputs on activities and topics. The Co-chairs will organise an online meeting to finalise the ToR and to start planning the activities.
