#### 1. Welcome Note

Co-chair (Europe) Ms. Gabriella Mallia welcomed the participants and informed them that the new Co-Chair (Asia) Ms. Duriya Amatavivat, Special Advisor, Ministry of Education, Thailand also joined this meeting.

## 2. The Terms of Reference for the Expert Group 1 SDGs and Education

Ms. Gabriella Mallia asked the participants if they had additional feedback to the Terms of Reference for the Expert Group 1 SDGs and Education. The updated ToR which was circulated by email included the feedback from Ms. Gonneke de Ridder, Policy Coordinator for UNESCO & SDGs, regarding widening the focus on the SDGs on all levels of education, not just on primarily higher education.

Co-Chair (Asia) Ms. Duriya Amatavivat recommended to add the 'interregional' level and to strengthen collaboration in SDGs. Ms. Gonneke de Ridder added that the 'local' level is important. Ms. Gabriella Mallia said the updated ToR will be sent to all members for their final feedback. The final TORs will be officially adopted at the Senior Officials' Meeting 1 that will take place in Malta on 22 and 23 May 2023.
